# REGULAR MEETING OF THE BOARD OF DIRECTORS Thursday, March 21, 2024

The Governing Board of the Southern Inyo Fire Protection District held a regular business meeting on Thursday, March 21, 2024 at 6pm at the St. Therese Mission in Charleston View.

## I. Call to order and determination of quorum

## II. Confirmation of Agenda/Reading of Minutes:

- A. Approve minutes from the February regular meeting. Zellhoefer moves to approve minutes as presented. McNeal seconds. Carries 4-0-0.

- A. Board Member Reports
  - a. Board Chair Report
    - b. Treasury/Budget Report
      - b.i. Lee moves to accept report as presented. Zellhoefer seconds. Carries 4-0-0.
      - b.ii. We did get an ambulance services payment. Doesn't seem to be on financials. Jerry will look into it.
- B. Fire Chief's Report
  - a. One call this month.
  - b. Training is going along well.
- C. Administrative Report
  - a. CalCard is now in effect and being used by the District.
  - b. Tax sale update. Our parcels in Charleston View will be available some time after the final tax sale on May 1<sup>st</sup>. The Board of Supervisors will set a price then.
- D. Fleet Mechanic's Report
  - a. State of Motor Pool
    - a.i. Brigadier is repaired and functional again, so fleet is good.
- E. Committee Reports
  - a. Water Kiosk
    - a.i. Received citation for failing to take a nitrate sample. Appropriate corrective actions being taken.
    - a.ii. Fiscally doing fine.
  - b. Fundraising
    - b.i. Close to \$12k brought in from rummage sale!
    - b.ii. Looking at art festival Halloween weekend.

## VII. Old Business

- A. Fire inspections
  - a. School board responded amicably in writing to inspection. Chief will need to review report.
- B. Fire water tower/firehouse update
  - a. Report from chief on new fire house progress
    - a.i. Infrastructure grant signed and we will have \$1.8M to build stations. Will be at least a year before we see any of the money. In meantime, Chief will continue to work with County.
- C. Recruiting and training EMTs and firefighters
  - a. Update on training class
    - a.i. Crew is training 20 hours/month alternating between medical and fire.
    - a.ii. Teaming with Pahrump on training and even with recruiting.
    - a.iii. EMT class starting 3/30.
  - b. CPR recertification course for current crew
    - b.i. Everyone expires in April. Need \$525 to recert everyone. McNeal moves to spend up to \$600 on this. Lee seconds. Carries 4-0-0.
- D. Update on radio communications
  - a. Still seeking info on pager/radios.
- E. Discussion of what travel is pre-approved
  - a. Zellhoefer moves to preapprove travel to Chief's meeting and EMCC meeting. Chief has authority to spend the \$1k in budget for travel. Anything above that, the board will need to address the budget. Lee seconded. Carries 4-0-0.

  - a. Sections for approval this month: IIPP (3010) and 3041
    - a.i. Zellhoefer moves to approve these as presented. Lee seconds. Carries 5-0-0.
  - b. Sections to review this month: 1000 & 1010
    - b.i. Zellhoefer moves to approve the draft. Lee seconds. Carries 5-0-0. Jerry will create final versions for approval next month.
- B. Threat to Sustainability
  - a. Zellhoefer moves that the board does not accept Cal Fire as a surrogate for any of our jurisdictional responsibilities. McNeal seconds. Carries 5-0-0.
- C. Uniforms purchase
  - a. \$509/person. 11 people. Zatarain moves to spend up to \$6k on the purchase. Lee seconds. Carries 5-0-0.
- D. Purchase of fire boots over and above Maddy grant
  - a. \$389/person for 3 people. Zatarain moves to spend up to \$1200. Lee seconds. Carries 5-0-0. Put on agenda to look at budget next month to allocate these expenses.
- E. Chief's report on SCBA tank quotes
  - a. Still researching grants. Will defer until next month.
- F. Allocate spending of \$25k from County
  - a. Defer until next month
- G. Adoption of the 2024 California Fire law for our AHJ
  - a. Flinchum will contact County attorney and perhaps have a special meeting to make an informed decision.
- H. Board officer elections
  - a. Zellhoefer moves to keep current officers in place. Zatarain seconds. Carries 5-0-0.
- I. Update on tax auction/Charleston View parcels
  - a. Zellhoefer moves to approve up to \$5k per lot to purchase at full price if it looks like they might be lost to us. McNeal seconds. Carries 5-0-0.
